GUIDELINES

I. ELIGIBILITY & TEAM COMPOSITION

1. Each team may consist of **one or two members**, with no limit on the number of teams registering from the same institution.
2. Students currently pursuing LL.B or LL.M. from any recognized university are eligible to participate.
3. **Cross-institutional teams are permitted**; students from different universities may form a single team.
4. **Team composition cannot be changed after registration without explicit approval from the organizing committee.**

II. REGISTRATION & PAYMENT DETAILS

1. Registrations will be accepted only through the **Google Form (Click Here)**.
2. **Registration Fee for a Team of Two: ₹ 499.**
3. **Registration for a Team of One: ₹ 299.**
4. The fee must be paid exclusively through the **CHRIST University web payment portal, Click the link below, Under: Events/Fests - Pnyx'26 (Click Here)**.
5. Teams must upload the payment invoice screenshot in the registration form.
6. **Registration fees are non-refundable under any circumstances.**

III. AWARDS

RULES

I. SUBMISSION

1. All teams must submit memorials for both sides (Petitioner and Respondent). Failure to submit memorials will result in disqualification.
2. Memorials shall be scored out of 50 marks per side, with the total memorial score being the average of both sides (out of 50 marks).
3. The criteria are:
 - Knowledge of Facts and Law (15 marks).
 - Quality of Legal Analysis and Argumentation (15 marks)
 - Organization and Structure (10 marks)
 - Adherence to Citation and Formatting Rules (5 marks)
 - Clarity and Language (5 marks)

II. STRUCTURE

1. Each memorial must include, in the following order: Cover Page, Table of Contents, Index of Authorities, Statement of Jurisdiction, Summary of Facts, Issues Raised, Summary of Arguments, Arguments Advanced, and Prayer.
2. The total page limit is 25 pages, inclusive of all sections. The Cover Page, Table of Contents, Statement of Jurisdiction, Summary of Facts, Issues Raised, and Prayer shall not exceed one page each. The Summary of Arguments shall not exceed two pages.

III. FORMAT

The Cover Page must include (centered, except for the Team Code):

1. The Team Code, clearly mentioned in the top right-hand corner.
2. The forum being approached (e.g., Supreme Court of India).
3. The nature of the case (e.g., Special Leave Petition, Writ Petition).
4. The name of the case (e.g., X v. Y).
5. The document title (e.g., “Memorial for Petitioner” or “Memorial for Respondent”).
6. The memorial must not reveal the team’s identity or participants’ names in any manner, except for the Team Code. Violation will result in disqualification.

- Formatting requirements:. Font: Times New Roman, Size 12., Line Spacing: 1.5, with justified alignment. Footnotes (not endnotes) must be used for citations, adhering to the 20th edition of the Bluebook citation format. Footnotes must contain only citations, not substantive text or examples.
- Memorials must be submitted in both “.docx” and “.pdf” formats via **Google Form** with filenames formatted as “TeamX_Petitioner” or “TeamX_Respondent” (Team numbers assigned post-registration).

IV. PENALTIES FOR MEMORIAL SUBMISSION

1. **Delay in Submission:** *Deduction:* 5 marks for every 15 minutes of delay.
2. **Missing Required Sections:** *Deduction:* 2 marks per missing section.
3. **Incorrect Citation Format:** *Deduction:* 20 marks per memorial (Petitioner/Respondent) for failure to use the prescribed citation format.
4. **Excessive Length:** *Deduction:* 2 marks per extra page beyond the prescribed limit.
5. **Formatting Violations:** *Deduction:* 1 mark per violation of font style, font size, or line spacing (capped at 10 marks per side).
6. **Plagiarism:** *Penalty:* Immediate disqualification of the team.
7. **Team Identity Disclosure:** *Penalty:* Immediate disqualification of the team.
